3. All vehicles will be out of the Festival grounds by 9:45am Saturday. Booths should be ready to operate by 10am. Booths must be open until at least 5pm Saturday. Vendors who leave early will not be asked to return to NTVRF events.
4. The undersigned hereby elects to and does release BASE CAMP LINDSEY and its respective offices, agents, and employees from any and all claims, demands, rights or causes of action of whatsoever kind or nature which the undersigned has ever had or may now have or may hereafter have, whether now known or which heretofore has ever or hereafter may be sustained by the undersigned as a result or in connection with or arising out of the undersigned's participation in Frontier Days.

## VENDOR GUIDELINES

APRIL 24-25, 2021

1. Two color photos of items to be sold MUST accompany all applications. All photos become property of the North Texas Veteran's Relief Fund. These photos are used in our social media advertising for the event. All vendors are encouraged to share the event on their related social media to ensure that your followers know where to find you.
2. Our theme for this event is 1800's Texas. We do not require, but do encourage all vendors to have fun with the theme. There will be a best booth contest judged by the attending public. The winner will receive a trophy and free booth space at next year's event.
3. All vendors are responsible for their own tables, chairs, and canopies. Volunteers will be available for limited assistance during unloading and set up.
4. Due to the Chuckwagon meal, Food Vendors may not sell anything other than snacks and novelty food items before 2pm, but you are welcome to stay through the Street Dance and even come back after the Sunday church service. Please contact the vendor POC if you have questions.
5. All vendor applications and fees must be submitted no later than 5pm on April 9th, 2021. Booths are based on a first come-first serve basis. Vendors will be notified of denial due to duplicate booths only. Unless notified otherwise your application is considered accepted upon receipt with required documentation and fees. If your application and fees are not received, you cannot set up.
6. Vendor parking: There will be no parking on the actual Festival grounds. Vehicles must be out of the Festival area by 9:45am Saturday, ~~no later~~, and cannot return until 5pm Saturday. Vendor parking is provided at a nearby lot. Vehicles pulling trailers must disconnect and park in the vendor parking area.
7. Proof of liability insurance is **required** of all food or activity vendors. This applies to vendors such as bounce houses or other physical activity that might involve risk of injury.
8. Texas sales tax: Collection and payment of sales tax on vendor transactions is a vendor responsibility.
9. **Don't forget: All vendors are required to furnish their own chairs, tables, awnings, umbrellas, etc.**
